# 29-State Utah Concealed Pistol Permit

[Recognized in 34 states for UT residents; only 29 states if not UT resident (e.g., CA resident)]

Why is an estate planning attorney offering you this course? Estate planning is having the right documents & training to protect your family & estate at key life events. Consider this SITUATION: Traveling outside California, you're walking down a deserted street with your wife and two small children. Suddenly, a dangerous looking man with a huge knife comes around the corner, locks eyes with you, screams obscenities, raises the knife, and charges. You have mere seconds before he reaches you and your family. What will go through your mind? **Hopefully not this ....**

Does the man look poor or oppressed? Have I ever done anything to him that would inspire him to attack? Could we run away? What does my wife think? What about the kids? What does the law say about this situation? Is it possible he'd be happy with just killing me? Does he definitely want to kill me, or would he be content just to wound me? If I were to grab his knees and hold on, could my family get away while he was stabbing me? Should I call 9-1-1? Why is this street so deserted? We need to raise taxes; have a paint & weed day; make this a happier, healthier street to discourage such behavior. So confusing!

Your brain on adrenaline will access (“crisis-scan”) any past training--no training, and you may well panic....Take this class and have more options!

- As of June 2008 recognized in 30 states (including Utah) as to non-Utah residents.
- NOT valid in California, but now traveling Californians can defend self & family
- Safety Training helpful where you may already carry in CA (e.g., home or business)
- US citizenship NOT required
- minimum age 21 & must pass background check
- Neither gun nor shooting experience required for class (class uses laser simulated range)
- Notary included after class; student responsible for Utah app fee (\$65.25), passport-style photo, fingerprints (& range fees, if any).

Note: Some states (e.g., CO, NH, MI, FL, WV) may require UT residency. Always check current law.

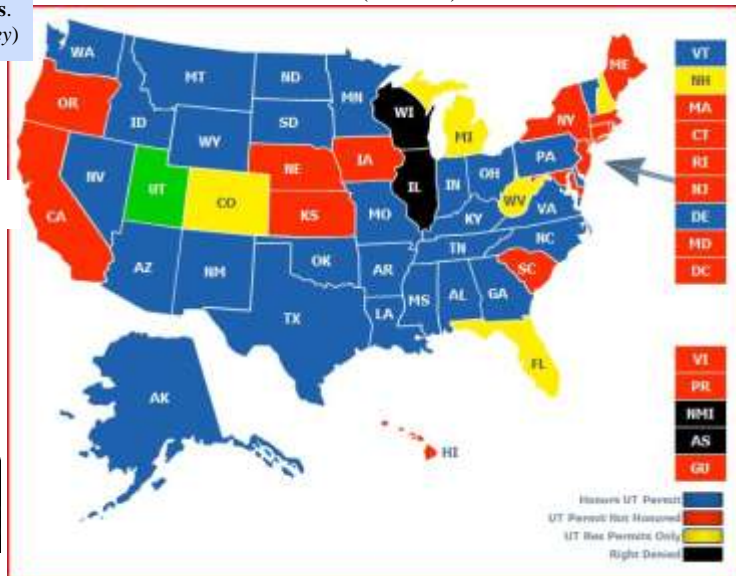
